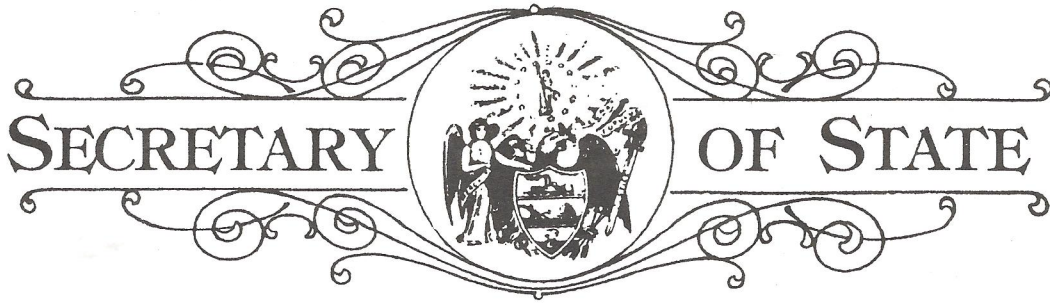

**ARTICLES OF INCORPORATION
OF
VAN BUREN COUNTY RESCUE SQUAD, INC.**

The undersigned persons acting as incorporators of a corporation under the Arkansas

Nonprofit Corporation Act of 1993 adopt the following articles of incorporation of such corporation:

1. The name of this corporation is **VAN BUREN COUNTY RESCUE SQUAD, INC.**
2. This corporation is a mutual benefit corporation.
3. The initial registered office of this corporation shall be located at 4848 Highway 65 South, Choctaw, Arkansas 72028. The mailing address of the corporation will be P.O. Box 152, Choctaw, AR 72028.
4. The name of the registered agent of this corporation at that address is Joey Weaver.
5. The incorporators are Joey Weaver, P.O. Box 152, Choctaw, AR 72028 and Lora Benedetti, P.O. Box 152, Choctaw, AR 72028.
6. The nature of the business of the corporation shall be:
 - a. The primary purpose of the corporation shall be to support and contribute to the improvement of rural firefighting and emergency services in Van Buren County, Arkansas.
 - b. The corporation shall have provisions not inconsistent with laws governing:
 - (1) Managing and regulating the affairs of the corporation;
 - (2) Defining and limiting and regulating the power of the corporation, its board of directors and;
 - (3) The characteristics, qualifications, rights, limitations, and obligations attaching to each or any class of users.

7. The period of existence for the corporation is perpetual.
8. The number of the directors constituting the initial Board of Directors shall be five (5).
9. That a voluntary dissolution of the corporation shall be made in accordance with A.C.A. 4-33-1401, etc., as it applies to mutual benefit corporations.
10. The Corporation shall have no members.
